IN LESS THAN FIVE YEARS, RENEGADE HAS BECOME ONE OF THE LARGEST FOSTER-BASED ANIMAL RESCUES IN THE COUNTRY. IN 2023 RENEGADE PURCHASED A BUILDING ALLOWING FOR IN-HOUSE BOARDING AND EXPANDED VOLUNTEER OPPORTUNITIES AND COMMUNITY PROGRAMMING. THE PRIMARY SERVICES ARE TO PROVIDE THE HIGHEST QUALITY CARE FOR ANIMALS THROUGH SHELTER, FEEDING, MEDICAL CARE, AND PREVENTATIVE TREATMENT UNTIL ADOPTION AND TO KEEP WANTED PETS IN HOMES THROUGH COMMUNITY-FOCUSED PROGRAMMING INCLUDING BASIC AND EMERGENT VETERINARY CARE, FOOD, SHELTER, AND EDUCATION.

THE ORGANIZATION DOES NOT KILL FOR SPACE BUT DOES PROVIDE COMPASSIONATE END OF LIFE AND HOSPICE CARE.OVER 600 VOLUNTEERS AND 300 FOSTER FAMILIES SUPPORTED THE ORGANIZATION'S EFFORTS. FOSTER HOMES SERVED 90% OF THE DOGS THAT ENTERED THE ORGANIZATION PRIOR TO THEIR ADOPTION.
