THE ORGANIZATION SERVES THE GREATER SAVANNAH, GA REGION, AND PARTNERS CLOSELY WITH NEARYBY COUNTY ANIMAL SERVICES IN GEORGIA AS WELL AS OTHER MUNICIPAL AND NONPROFIT GROUPS AND IS ONE OF THE LARGEST FOSTER-BASED ANIMAL RESCUE CENTERS IN THE COUNTRY. WITH THE PURCHASE OF A BUILDING IN 2023 WHICH ALLOWS FOR IN-HOUSE BOARDING, EXPANDED VOLUNTEER OPPORTUNITIES, AND COMMUNITY PROGRAMMING, THE ORGANIZATION IS ABLE TO PROVIDE QUALITY CARE FOR ANIMALS THROUGH SHELTER, FEEDING, MEDICAL CARE, AND PREVENTATIVE TREATMENT UNTIL ANIMALS ARE ADOPTED. IN ADDITION, THE ORGANIZATION WORKS WITH VOLUNTEERS TO FOSTER PETS IN HOMES THROUGH COMMUNITY-FOCUSED PROGRAMMING INCLUDING BASIC AND EMERGENT VETERINARY CARE, FOOD, SHELTER, AND EDUCATION.

THE ORGANIZATION PROVIDES MEDICAL CARE FOR ANIMALS IN NEED, PRIMARILY DOGS. MEDICAL CARE INCLUDES SPECIAL SURGICAL NEEDS SUCH AS SPAY AND NEUTER SURGERIES FOR ANIMALS IN CARE AND FOR COMMUNITY PETS. ANIMALS ARE TREATED FOR HEARTWORMS AS WELL AS RECEIVING VACCINES AND MICROCHIPS.

DURING THE YEAR, 49 ANIMALS WERE TRANSPORTED TO RESCUE PARTNERS, 1,129 DOGS RECEIVED CARE AT THE CENTER, AND 1,166 FAMILIES SERVED AS FOSTER FAMILIES WHICH RESULTED IN 95% OF RESCUED ANIMALS IN FOSTER CARE. THE ORGANIZATION HELD 4 WEEKLY ADOPTION EVENTS, SERVING 8 COUNTIES. AS A RESULT OF FOSTERING SERVICES AND ADOPTION EVENTS, 1,171 ANIMALS WERE ADOPTED.
